The Board of Supervisors of Clinton County, Iowa, met. Present were Supervisors Determann, Irwin and Srp. Minutes of the previous meeting were read and approved.

9:00 A.M. Review Correspondence and Claims Call to Order – Pledge of Allegiance

Coronavirus/COVID-19 update: County Community Health Manager Michelle Cullen reported 166 new cases were reported in the County in the last ten days with 540 active cases which has been consistent. Cullen said Mercy is up to seven hospitalizations and Genesis is up to 33. She said they are back to watching those levels of hospitalizations. She said three more have died from COVID in the County since last week. A total of 72 Clinton County residents have died from COVID, Cullen reported. She said one long-term care facility is still in outbreak status but under control. Cullen said the positivity rate is at 12.5% and holding consistent. She reported more than 2,600 vaccines have been given to health care employees, nursing home clinics and those in the 1A group. She said 1B vaccination group will start today. Cullen said the County is receiving 1,100 doses within the next two weeks. She said EMA has arranged a COVID outreach line that will include a recorded message about how people can get immunizations. Cullen said people can call the pharmacies to ask them about how they are distributing the immunizations.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Engineer Todd Kinney reported the Drainage District #7 pre-quote meeting is on Thursday. He said bids will be due the following week and he said there has been more interest than expected in the project.

County Treasurer Dustin Johnson reported about \$100,000 in tax collections came in last week. He said his office has been busy on this first day of the County buildings being open.

DISCUSSION WITH POSSIBLE ACTION

YWCA Funding Request: Supervisor Srp explained the YWCA has requested a special request of \$15,000 to help that organization due to a shortfall in grant funding and increased expenses incurred due to the COVID-19 pandemic. EMA Director Chance Kness said he is working with the YWCA, the County Community Assistance and the local Information Referral organization to work on public assistance through FEMA. He said a meeting is scheduled for this afternoon. Kness said an issue could be the upfront funding that may be needed before the reimbursement comes from FEMA which could be three to six months. Chairman Determann reminded the Board the request was specific to hire more help to answer their phones to decrease their response time to less than 48 hours. Srp said he would reach out to the YWCA officials to invite them to join a discussion next week.

FY22 Budget Work Session: The Board reviewed the proposed FY22 budget work session.
