## CLINTON/JACKSON EARLY CHILDHOOD IOWA BOARD MEETING MINUTES

## February 22, 2021

This meeting was held via Zoom due to the Covid-19 restrictions on gatherings.

C/J ECI Board Meeting Called to Order/Roll Call: Jack Willey called the meeting to order at 4:00 p.m. Gwen Deming conducted roll call: Members present listed.

January 25, 2021 Minutes: Gwen Deming presented the minutes from the 1/25/21 C/J ECI Board Meeting. Jim Irwin made a Motion to approve the Minutes as presented; Peggy Sellnau seconded the Motion; all Ayes, Motion carried.

Bertelsen Education / CCR&R Training: Jill Bertelsen from Bertelsen Education and Lori Mueller from Child Care Resource & Referral each gave an overview of their training opportunities for child care providers in Clinton & Jackson Counties. The board made comments and asked questions about current services, including costs for training.

**Director's Expenditure Report:** Gwen Deming presented the Director's Expenditure Report for review, and noted there were 37 preschool scholarships funded in January, which brings the total cost to date at \$18,650. She also stated Easton Valley reached out for information about scholarships and was sent the mini-grant application. Jim Irwin made a Motion to approve the expenditure report as presented; Jessica Ihns seconded the Motion; all Ayes, Motion carried.

FY2021 Site Visits: The schedule for site visits (March 1, 2021 - March 4, 2021) was shared with the board members. Gwen stated she would send out the site visit reports, along with the Zoom meeting information for each visit. Board members were asked to read through the reports and email any questions before the site visit. Board members were also invited to attend one or more of the site visits. Bright Beginnings requested a few C/J ECI Board Members to attend their credentialing meeting on 3/2/21 @ 9:00 a.m. Two board members, Sarah Hogan and Jim Irwin, agreed to attend.

FY22 Contract Renewals: The C/J ECI Board discussed contract renewals vs. RFPs for FY2022. Since the board is going through the Community Plan this year, it was decided to release contract renewals for all programs except Head Start. The Hawkeye Area Community Action Agency (HACAP) has taken over Head Start in Jackson County. Currently, C/J ECI does not fund Jackson County Head Start but would like to allow them to apply. Jessica Ihns made a Motion to release renewals for all current contracts except Head Start, and to release a Request for Proposal (RFP) for Early Head Start and Head Start Expanded Day in Clinton & Jackson Counties; Peggy Sellnau seconded the Motion; all Ayes, Motion carried. Community Plan: To date, 41 parents and 24 providers have completed the surveys that were shared. These surveys will be available through March 31, 2021. Both electronic and paper copies have been sent to providers for parents/caregivers to complete. The 0-5 in 60 Minutes meetings have been facilitated since December to allow for communication among 0-5 providers, as well as gain direction and ideas from providers.

2nd Quarter Reports: The 2nd quarter reports were emailed to board members for review. No comments or questions at this time.
