The Board of Supervisors of Clinton County, Iowa, met. Present were Supervisors Determann, Irwin and Srp. Minutes of the previous meeting were read and approved.

Coronavirus/COVID-19 update: County Community Health Manager Michelle Cullen reported 27 new cases in the last seven days and only five in last three days. She said hospitalizations have remained consistent with last month with 51 in the region including 16 at Genesis and three at Mercy. Cullen said the positivity rate is down to 6.4% from 7%. She said the vaccination rate is at 38%, but demand for the shots are decreasing. She said Public Health is starting walk in clinics this week and also starting homebound patients this week. Cullen anticipates the CDC may soon start allowing shots for people as young as 12 years old. The Board discussed the mask policy in County buildings and has decided to keep its current policies in place and continue to monitor CDC and OHSA guidelines.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reported his office is conducting interviews this week for the Election Coordinator position.

County Facilities Director Corey Johnson said the materials for the roof project will be here tomorrow. He said six roofers will be working on site until it is completed. He said the old air control system equipment will be removed this week. He said a large crane will be on site during that job.

County Treasurer Dustin Johnson said \$380,000 of delinquent property tax was collected last week as a result of delinquency letters being sent. He said the outstanding property taxes are \$426,000 from the 2018 tax year and \$1.63 million from the 2019 tax year. He said the tax sale is June 21.

County Conservation Director Phillip Visser said two park supervisors started today which will help get the department back up to full staff and seasonal employees are also starting this week. He said cabin and camp site reservations are filling up.

Supervisor Irwin said the legislation is still meeting on bills concerning back fills to counties and mental health funding. Irwin said the Assessor's Office is interested in placing shields in their office such as what the Treasurer's and Auditor's Offices feature.

Supervisor Srp reported he is staying in touch with the group in town that would like to receive money from the federal Rescue Funds to addresses homelessness.

DISCUSSION WITH POSSIBLE ACTION

American Rescue Plan Funds Planning: Van Lancker said he and Budget Director Nicholas Manrique have done some research during the last few weeks and presented a starting plan for the Supervisors to consider. That plan included budgeting \$1.5 million for the County to retain, \$2 million budgeted to assist local non-profits with losses or added expenses they realized due to the pandemic in 2020, and the remaining \$5.5 million toward broadband improvements around the County. Irwin said he's not interested in doing bonuses for employees who worked during the pandemic. Srp said he doesn't disagree with Irwin, but said he would listen to requests from departments if they believe it is justified.

MOTION by Supervisor Irwin to authorize the chairman to sign the agreement with SmartSource for a broadband study of the County.

RAGBRAI Vendor Guidelines: Supervisor Irwin said he asked the sanitarian and zoning heads for input on this matter. Irwin said fees seemed to be all over the place and wasn't sure about the regulations. County Sanitarian Shane McClintock said the vendors have to apply through the RAGBRAI organization and they would have to meet certain criteria set by the State. He said that would keep the amount to a minimum. County Zoning Director Thomas Barnes said it is mostly through the State for a temporary easement and there is a fee structure set up for that. Van Lancker reported that temporary liquor license process starts with the State before coming to the Board for local authority approval. McClintock said many counties are not setting up their own ordinances as the vendors have to go through the State. He said it would also be very late to start writing and approving ordinances.

Sheriff's Office Door Replacement: County Facilities Director Corey Johnson said the contractor ordered the wrong door and it is currently under dispute with that contractor. He said the new door and installation would cost approximately \$12,000. He said it would take 12 weeks to have the new door delivered.

MOTION by Supervisor Srp to authorize building maintenance to order the replacement door and have it installed.

10:00 A.M. Iowa Drainage District Association (IDDA) Annual Report

IDDA Executive Director John Torbert reported the legislature is still in session to finalize some budget issues. He said policy issues could arise out of the budget discussions so they are still paying attention to what is happening in Des Moines. Torbert said legislation was approved to address several items including less publication rules for reclassifications; increase the threshold to retain an engineer for a drainage repair; addresses the competitive bid threshold to set it at \$139,000; and provisions to allow for informal notice of drainage activity. He said these provisions take effect July 1.

The Board of Supervisors adjourned to meet on Monday, May 17, 2021.
