The Board of Supervisors of Clinton County, Iowa, met. Present were Supervisors Determann, Irwin and Srp. Minutes of the previous meeting were read and approved.

Coronavirus/COVID-19 update: County Community Health Manager Michelle Cullen reported numbers are up just a little from last week, but mostly steady. She said there are 236 active cases in the county, 26 new in last seven days and two new in the last three days. She said regional hospitalizations are at 40 with 14 at Genesis and five at Mercy. Cullen reported the positivity rate is at 4.8%, down from last week. She said the vaccination rate in the County is up to 40% and climbing slowly. Cullen said clinics are now starting for 12 and older. She said public health is hosting a clinic on Thursday and pharmacies have started vaccinations already this week for the younger population.

RESOLUTION 2021-137 discussion: County EMA Director Chance Kness explained the changes include that the County conducts two fire drills at its building each year and includes expectations. County Treasurer Dustin Johnson said there is a cost to his office when they have to delay work for a fire drill. Julie Bray, local insurance agent for the County reported that loss control is in support of the County's current standards. She said the County's actions do result in loss reduction as she reports the steps the county takes. She added a lawsuit after an incident would be easier for someone to file if the County didn't take these risk prevention steps.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker asked the Board if it would like to meet the week of Memorial Day as the County is closed for business on Monday. It was agreed the next Board meeting would be scheduled for June 7. He asked the Board if there were any objections to the Clinton Substance Abuse Council placing signs in the County property lawns. There were no objections.

Supervisor Irwin reported the resource center has been staffed the last week and they are working through some issues to make it better. Supervisor Srp said the judicial district funding the position for that resource center has been huge toward the center's success.

Supervisor Srp said a grand opening for the Eden Valley Nature Center expansion is at 1 p.m. May 29. He said at 6 p.m. June 23 a dedication of the Peterson Addition at Eden Valley will be conducted. He added that the Conservation Board took action last week to close the Enterprise Zone and transfer the remaining funds into the Conservation Department land acquisition fund.

Chairman Determann said on Thursday there was a preconstruction meeting for the Elvira Wastewater Project. He said the project will start in June and could take up to 2-3 weeks depending on the weather.

Kness reported his office will put out a release soon for a reboot of Alert Iowa. The program allows people to receive texts and emails about pending severe weather. Alert Iowa is switching vendors which will cause the reboot and users will have to sign up with the new system to continue to receive alerts.

County Engineer Todd Kinney reported rock hauling is in full swing. He said the Z-24 grinding project east of DeWitt is done and they will move to the Elwood Road grinding project.

County Facilities Director Corey Johnson said the roof project at the Administration Building continues after a rainy last week. He said the parking lot plan for employee parking will be going out soon as that project starts June 14. He said an inmate last week was able to break a sprinkler head in a holding cell. He said the front doors to the Law Center are being worked on now.

DISCUSSION WITH POSSIBLE ACTION

Risk Management Committee Update: Kinney said he shared a draft letter to the Board they could send if certain departments aren't as responsive as they should be with Risk Management Committee recommendations and trainings. Van Lancker spoke about the insurance premium reductions over the years since Clinton County started their risk management program. He said they have reduced from \$200,000 to under \$100,000 last year. Kness said there is leeway given for departments that have something critical going on during a drill. Srp is worried a fiscal penalty could hurt services to taxpayers. Irwin said that could be discussed during budget time. Srp said a public discussion could take place before a budget discussion.

County Tax Suspension Policy: The Board reviewed the policy with General Assistance Director Kim Ralston. She said there are currently 27 property owners who have been granted a property tax suspension through Code of Iowa Section 427.8. She added there are a couple who regularly apply that she has not heard from this year. She said the people requesting the suspensions range in age from 51 to 93 with the average age at 68. She said they may be eligible for the tax suspension policy, but may not qualify for some of the property tax credits as she is able to remove medical claims from income guidelines. Ralston was going to work with the County Treasurer's Office to update portions of the policy.

American Rescue Plan Funds Planning: County Auditor Eric Van Lancker said he is hearing the issues with signing in for the funds has been resolved. He said his office will work on signing in later this week. Determann said he doesn't support using the funds for premium pay. Irwin agreed he isn't there for premium pay right now until it is more defined how the money can be used.
