The Board of Supervisors of Clinton County, Iowa, met. Present were Supervisors Determann, Irwin and Srp. Minutes of the previous meeting were read and approved.

9:00 A.M. Review Correspondence and Claims Call to Order – Pledge of Allegiance

9:15 A.M. Formal Action & Motions Claims were approved unanimously

Coronavirus/COVID-19 update: County Community Health Manager Michele Cullen reported there were 117 new cases in the last seven days in the County with 15 of those in the last three days. She said the region hospitalization is at 130 with five at Mercy and 26 at Genesis. Cullen said nine Clinton County residents are currently hospitalized. She said the County positivity rate is 14.5% and the vaccination rate is at 49%. Cullen mentioned that public health will host another vaccination clinic on Tuesday.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reported the Clinton County WhereUVote app is now updated for the November 2 City/School Election. He said it will be helpful as some polling locations have changed. He added that the County broadband survey has been extended through Oct. 15.

Supervisor Srp said he had a few employees contact him after the letters were sent to them about providing vaccination records. Srp said employees didn't feel that sharing vaccination records was optional, but he told them it was. He said he also told them the final rules for it have not yet been submitted. Supervisor Irwin said he also had some of the same calls. He said HR Attorney Amy Reasner is planning on joining the Board meeting on October 18 to discuss some of the options of federal vaccination mandate.

Chairman Determann said there will be meetings about a solar project in Ground Mound tomorrow.

County Engineer Todd Kinney said the Old HWY 30 project is ready for paving and may not start for another week or two.

County Conservation Director Phil Visser reported there is a Halloween event at Rock Creek this weekend.

County Treasurer Dustin Johnson said they had a good month of property tax collections in September. He said his staff did a good job handling the surges of residents during the tax collection time.

DISCUSSION WITH POSSIBLE ACTION

Opioid Litigation Update: County Attorney Mike Wolf reported the litigation has settled and that Iowa will receive money soon. He said it could mean \$172.8 million for Iowa over 18 years. He said the settlement requires an agreement between the state and the counties and they have been meeting about allocation agreements. He said they are meeting with the State again this week. Wolf said the Attorney General is asking for a split of 75% to State and 25% to the counties. He said that is the leanest deal for counties in the country compared to other states. Wolf said Clinton County is set up in a way it can use those funds and the attorney general office has acknowledged that. He said a majority of the funds must be used on opioid prevention and treatment. He said some counties don't want or need those allocations and would like the state to reallocate those funds to the counties that could use the funds. He said the counties are looking for a split that would include 60% to the county. Wolf suggested the chairperson of the Board be the official vote from Clinton County for the settlement agreement when that time comes.

MOTION by Supervisor Srp to appoint the Chairman of the Board of Supervisors as the representative to vote for the County on the pending allocation agreement with the state.

Roll Call: Srp: Yes; Irwin: Yes; Determann: Yes. Motion carried.

County Administration Building Maintenance Projects Update: County Facilities Manager Corey Johnson reported the electrical engineer has presented a report with three options for the generator and reviewed those options. He said Option 1 is estimated at \$16,000; Option 2 is \$398,000; and Option 3 is estimated at \$143,000. He said Option 2 and 3 have the same outcome, but Option 2 has one transfer switch which is easier, but more expensive to replace. He said Option 3 includes multiple switches which will cause more maintenance, but the rest of the building not on a downed switch would continue to operate. He recommended Option 3 because the difference in cost could equal the maintenance on the multiple transfer switches for several years. He said one transfer switch is less maintenance and reduces the chances of things going down. He said all switches would be tested weekly like the current switch and generator are. Srp suggested going ahead with Option 1 and then do Option 3 after the budget process for the next fiscal year. Srp asked Johnson to research how quickly Option 1 can be done.

MOTION by Supervisor Srp to authorize maintenance to proceed with Option 1 scope of work as soon as possible.

Roll Call: Srp: Yes; Irwin: Yes; Determann: Yes. Motion carried.

Supervisor Irwin wondered if the engineer should start with the documents for Option 3 so they are ready to go to bids. Johnson said there will need an Option 1 budget amendment and would suggest they just add the plans for Option 3.

Johnson said the bearings are being replaced in the air handler on the north side of the building, but it will take 9-12 months to replace the unit. He said they are waiting on an estimate for that replacement. He said it could be bid through Sourcewell or have it engineered through a firm. He said with Sourcewell the state sets the amount of the project and collects bids from certified contractors to complete the work. He said they have used Sourcewell for purchasing things such as mowers and Sourcewell will be the quicker process. Johnson said the estimate for the replacement is around \$400,000.

MOTION by Supervisor Srp to proceed with project pricing on the air handler through the Sourcewell system.

Roll Call: Srp: Yes; Irwin: Yes; Determann: Yes. Motion carried.

Johnson said the parking lot should be paved by the end of this week and the lot will be striped on a weekend. He said the fire panel at the Courthouse cannot be replaced as it exists. He said the short in the panel needs to be replaced, but the board replacements are no long manufactured. He is collecting estimates to replace the fire panel.

County ARP funding update: Supervisor Irwin said he asked for this discussion after receiving an email from the County Engineer. Van Lancker and Budget Director Nicholas Manrique reported the deadline to file the first quarter report has been moved back a month. Irwin and Manrique are currently working on the ARP grants that are specific to address homelessness.

Chairman Determann called a public hearing to order to solicit comments on a CDBG application for public facilities grant at the Gateway Area Community Center.

Proof of publications was presented, accepted and returned for filing.

Present were Supervisors Irwin and Srp, County Auditor Van Lancker, public and media.

Srp said he received support from the contractor for the project that the proposed upgrades are needed for the sustainability of the building.

Jorge Rodriguez of the Gateway Area Community Center reviewed the project that includes improvements to the building's kitchen, roof and heating. He said this work is not a want, it is a need. He said the center assists students and also provides hundreds of pounds of food through their services. He added that the upgrade to the climate control would cut their power bill by 50% and those funds could be invested in their programs. He said they also

provide food pantry services in Camanche. He apologized for any miscommunications that may have happened previously.

Kelley Brown of ECIA read a statement...This is a public hearing to solicit comments on the County’s proposed application for a Community Development Block Grant – CV Public Facilities Grant to the Iowa Economic Development Authority. The Gateway Area Community Center provides valuable support to Low- and Moderate-Income families and individuals in Clinton County, Iowa. The application will be submitted to IEDA no later than December 31, 2021. The proposed 2021 Public Facilities grant will be in an amount not to exceed \$500,000 potentially including a roof replacement, new HVAC system, new security system, kitchen reconstruction and additional storage units. The matching funds will be the responsibility of the Gateway Area Community Center. Clinton County will be the applicant and will not be contributing financially to the project. The proposed project meets the HUD national objective for serving LMI families and individuals. By design, no displacement will occur. If displacement is necessary, the County will comply fully with the Uniform Relocation Act and Section 104(d).

MOTION by Supervisor Srp to adjourn the public hearing.

Chairman Determann called a public hearing to order to solicit comments on a CDBG application for food pantry grant at the Gateway Area Community Center.

Proof of publications was presented, accepted and returned for filing.

Present were Supervisors Irwin and Srp, County Auditor Van Lancker, public and media.

Jorge Rodriguez, representative of the Gateway Area Community Center, said the grant would address refrigeration issues at the center and will reduce power bills.

Kelley Brown of ECIA read a statement ... This is a public hearing to solicit comments on the County’s proposed application for a Community Development Block Grant – CV Food Bank/Food Program Assistance Grant to the Iowa Economic Development Authority. The Gateway Area Community Center provides valuable support to Low- and Moderate-Income families and individuals in Clinton County, Iowa. The application will be submitted to IEDA no later than December 31, 2021. The proposed 2021 Food Bank/Food Program Assistance grant will be in an amount not to exceed \$100,000 potentially including all new kitchen appliances and funds for the additional food needed to sustain the growing number of food insecure people who were compromised because of COVID 19. The matching funds will be the responsibility of the Gateway Area Community Center. Clinton County will be the applicant and will not be contributing financially to the project. The proposed project meets the HUD national objective for serving LMI families and individuals. By design, no displacement will occur. If displacement is necessary, the County will comply fully with the Uniform Relocation Act and Section 104(d).

MOTION by Supervisor Srp to adjourn the public hearing.

Srp asked if ECIA needed more directions this week. Brown said they won’t move forward without an indication that the County is willing to sponsor the applications. Supervisor Irwin said he has been frustrated with the process. He said it started with an application for the facility and then there was no indication there would be two other applications. He said also during a separate meeting the gateway representatives walked out of the meeting when questioned about some things. Irwin said the Board committed to the CDBG application weeks ago and he’s comfortable moving forward with the two CDBG applications that will benefit the community.
