Coronavirus/COVID-19 update: County Community Health Manager Michele Cullen reported 127 cases in the last week which is up 10 from the previous week. She said the hospitalization rate is down slightly to 108 in Region 5 with Genesis having 21 and Mercy with three. Cullen reported the 14-day positivity rate is up to 17.1% but that indicated providers are testing the sick people. She said the County vaccination rate is slowly increasing up and is now at 50%. She added vaccination clinics continue every Wednesday in her office and pharmacies continue to offer vaccinations as well.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reported absentee voting for the November 2 City/School Election will begin on Wednesday. He mentioned voters who want a ballot sent to their home must have their request into the Auditor's Office before 5 p.m. on Monday, October 18. Van Lancker also reminded the Board it would canvass the votes of the November 2 election at 1 p.m. on November 8. He said the second canvass will be scheduled for 9 a.m. on November 15. It was decided to have the canvass at 1:30 p.m. on November 8.

County Engineer Todd Kinney reported dust control is starting to be bladed. The 190th Street project is completed. He said Old HWY 30 east of DeWitt paving is expected to start sometime next week.

Supervisor Srp said he encouraged the humane society to submit a request for County support as they reported more animals from the County are being dropped off at their facility.

Supervisor Irwin said the DeWitt Library Board voted last week to allow Charlotte and Delmar to use their facility going forward. He said the Region Mental Health Board conducted a budget meeting last week and concerns with the agreement with the State were passed along to the State.

County Sheriff Bill Greenwalt said he appreciated that the County has an HR department and training. Greenwalt said the new jail is averaging 81 inmates in the jail, but they are currently at 86. He said staffing is not designed for that many. He said there are about 10 from outside the County which may need to be sent back due to the increased number of inmates. He said one Saturday night recently they booked in 13 inmates. He said they have been notified by the food vendor to expect an increase of 15-20% in cost of food services. Greenwalt said the County Attorney has asked that some crimes be allowed back in the jail as a deterrent. He said he will review those policies during an upcoming meeting with the County Attorney and other law enforcement agencies in the County.

Chairman Determann said the solar project open house last week in Grand Mound went well and there was a lot to learn. He will also be attending the DOT meeting in Waterloo tomorrow to support railpark projects in front of that board.

County Treasurer Dustin Johnson said property tax collections continue. He said there are less than \$900,000 left from previous years with a vast majority of that from the former Ashford property. Johnson said eventually properties like the Ashford property that don't pay property tax become controlled by the County and those properties can be transferred to the city where it is located. He said he has been contacted by the mortgage company that has a lien on the property. He said they could step up to take action before it is turned over to the County.

County Facilities Director Corey Johnson said the bathroom plans for the Administration Building are getting ready to go out for bid. He said bids will be returned on November 16. He said snow removal bids will go out this week for the DeWitt office. He said those will come back later this month. Johnson said hopefully the parking lot will be paved by the end of the week, but it will depend on the weather.

DISCUSSION WITH POSSIBLE ACTION

County Prescription Benefits Manager Update: Van Lancker said the Health Benefits committee has met to review the information received through an RFP for a prescription benefits manager. He shared the report with the Board and asked consultant Aaron Viertel to review the information with the Board.

MOTION by Supervisor Srp to authorize the County's pharmaceutical consultant to proceed with obtaining an agreement with True RX.

County-Wide Training Day Update: HR Director Dawn Aldridge said the Risk Committee is recommending an all-day training for employees on December 15. She said this would include active shooter training as there are many new hires in the County who have not yet participated in that training. The Board asked if the tenants in the Administration Building were aware of the proposal to close the building. Van Lancker said he would reach out to them about the building closing and invite them to the training. He will report back next week.

Outside Attorney Procedures: It was decided to review this topic next week when the County Attorney may be available.
