WHEREAS, the Clinton County Communications Commission has authorized the hiring of additional staff and the Board of Supervisors does not consider or appoint personnel for the Communications Commission, but needs to authorize payroll for the County Auditor. Clinton County Communications Director Eric Dau desires to appoint Danielle Andersen as a Telecommunicator for the Clinton County Communications Commission; now

RESOLUTION 2022-100

WHEREAS, the Clinton County Board of Supervisors, upon recommendation from the Clinton County Director of Human Resources, wishes to update incentives for the Clinton County Employee Wellness Program to promote participation in the program; and

WHEREAS, the employee incentives would be added to the employees' health benefits deductible starting in 2024 for certain program thresholds met in 2023; and

WHEREAS, said program thresholds include:

- An additional \$250 each for the employee and spouse toward their family deductible or an additional \$250 for the employee deductible for an employee on a single plan by submitting a health risk assessment, completing an annual health screening, participating in the follow up consultation and qualifying in either the low or moderate risk categories
- An additional \$250 each for the employee and spouse toward their family deductible or an additional \$250 for the employee deductible for an employee on a single plan by submitting a health risk assessment, completing an annual health screening, participating in the follow up consultation and if determined to be in the high risk category, then participate in monthly health coaching in 2023.

THEREFORE BE IT RESOLVED by the Clinton County Board of Supervisors that the Human Resource Director be and is hereby authorized to administer the said changes to the Clinton County Employee Wellness Program.

RESOLUTION 2022-101 discussion: Supervisor Irwin would like to reduce the recommendation in half so the elected officials, except the Sheriff would be at 3% as set for other employees in the county. Chairman Determann said he doesn't want current electeds to fall behind again in compensation compared around the state, but he would recommend the Supervisor salary be reduced to 3%. Supervisor Srp said he wants to give credit to the comp board on how thoughtful they were with its recommendation. He said they were also respectful to our taxpayers. Srp said he's willing to support Determann's recommendation. He said a fair salary is essential to attract good decision makers to the County. Irwin said no incumbents have anyone running against them. He said he could live with a 25% reduction. Determann said the County has one of the best compensation boards in the state. Determann said other Boards have already approved large salary increases and doesn't want to see Clinton County fall behind again. Srp agreed Clinton County could fall behind pretty quickly and he's seen it happen in his time on the Board.

RESOLUTION 2022-102 discussion: Determann heard about an increased budget due to having to hire at the jail. However, he explained it is needed for the safety of the staff and inmates. Srp said some of this can offset by housing outside of the county inmates. Sheriff Bill Greenwalt said they review every week how many out of county inmates they can accommodate. He said they currently have more than 20 out of county inmates which would bring

in revenue of \$40,000 in a month. Irwin thanked the Sheriff for keeping the Board up to date as well as all of the other elected officials. Irwin added the County directors are also good about updating the Board on what is happening and how those situations affect the County budget. Srp said there were opportunities to be more aggressive about lowering the tax levy rate, but the County also knows it is important to maintain the amount of services provided by the County.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker said nomination papers have been received for the Primary Election. He added that Wednesday is the last day to withdraw nomination papers and the last day to object to nomination papers is Friday. He said voters may start submitting requests for absentee ballots for the Primary on Tuesday. He added the Special Election for Calamus City Council on April 12 is in full gear.

Supervisor Srp said the CCJCC met last week and it has a vacancy which is appointed by the Commission.

Supervisor Irwin reported the Mental Health Region awarded the DeWitt service provider with the grant it requested.

Chairman Determann said the meeting in Grand Mound about the solar projects went well and everyone was able to share their thoughts with the Board. He said he heard from Union Pacific that they are waiting to receive permits to continue work on the railroad bridge over the Mississippi River.

Sheriff Greenwalt said a recent incident reminded him how dedicated the volunteer fire departments are around the County. He said they are trying to appoint a civil service member and it is a Board of Supervisors appointment. He said he has had a couple of people express interest. He said the Civil Service Commission can continue to work with just two, but will try to get a third appointed as deputy hiring is coming up soon. Greenwalt said it was great to see so many elected officials from across the County at community events during the weekend.

County Treasurer Dustin Johnson said the office is busy as it is the last week of property tax collections for second half payments.

County Community Assistance Director Kim Ralston wanted to follow up on the indigent cremation policy. She said she shared the proposed changes with the local funeral homes a couple of weeks ago and has not heard anything back. She said a family recently asked for assistance with a funeral home bill to transport a family member to the University of Iowa for its medical program, however it doesn't qualify under current policy. She will prepare a resolution to update the policy for the Board to consider.

County Engineer Todd Kinney provided an update on projects. He said the deck pour on the bridge south of Grand Mound will begin tomorrow. He said contract rock hauling bids will be sent out this week.
