DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reported on upcoming elections in his office. He reminded the Board again he may need to hire temporary part-time in his office during the election to assist during a medical absence in his office. He said he will present resolutions next week setting pay for Election Day employees.

Supervisor Srp said there will be an extra conservation meeting this week to approve a grant application that is due with the CCDA.

Supervisor Irwin said Workforce Development is meeting Wednesday.

Chairman Determann attended a public meeting on proposed roundabouts on Mill Creek Expressway.

County Treasurer Dustin Johnson said his office is working through a credit card vendor change starting tomorrow. He said tax billing is proceeding on schedule. He said he submitted legislative proposals to address elderly property tax credits.

County Facilities Manager Corey Johnson reported the administration restrooms continue to get near completion as grouting has started this week.

DISCUSSION WITH POSSIBLE ACTION

Township Officials Update: Stanley Teal, Elk River Township Clerk, said the cemetery administration is quite a bit. He wondered when the Board had last visited pay for township officials. He asked if he could charge funeral homes and monument companies for his time. He also asked about being paid for selling plots. Irwin said the cost of selling a plot should include some of the fees that Teal mentioned. Van Lancker suggested the Board could address the payroll for township officials, but the other administrative matters depend on the elected township officials. Srp agreed with Van Lancker and suggested Teal speak with the County Attorney about what township officials could charge with cemetery administration.

Proposed Wolf Carbon Solutions Carbon Capture and Storage Pipeline Project: Chairman Determann said Wolf is asking for the name and contact information for the County's inspector so they can share it at the Aug. 30 public meeting. County Engineer Todd Kinney said the County is not obligated to have someone by the public meeting. Kinney said during the last project an inspector was shared with Scott County. Kinney said the Wolf permit has not yet been approved. Determann emailed Wolf and asked if they would start paying for an inspector, but he has not yet heard back. Kinney said he will work with Scott County to work on coordinating an inspector.

Service Contracts for the Administration Building Boilers and Chillers: County Facilities Manager Corey Johnson reported he has two proposals. He said the one proposal did not provide a breakdown that was asked for last week.

He said it will be about a 35% increase in the service contract fee. He said they can wait as the current service contract is good for six more months. Johnson will ask the vendors for a three year estimate and more updates.

Elvira Wastewater Updates: Irwin was hoping to host a meeting in Elvira. Srp suggested a certified letter be sent to the residents about what they should expect now that the system has been installed. Van Lancker said the system is now the property owner's system. He said the County helped finance it, but it now belongs to the landowner for maintenance. Srp said he could work with the sanitarian on a mailing to the residents and bring it back to the Board for approval.

10:01 A.M. Public Hearing

Chairman Determann called a public hearing to order to solicit comments on a proposed transfer of county-owned land to the Clinton YWCA as part of its National Housing Trust Fund (NHTF) application for a supporting housing project.

Proof of publications was presented, accepted and returned for filing.

Present were Supervisors Irwin and Srp, County Auditor Van Lancker, YWCA officials, public and media. YWCA official Angie Bloomfield addressed the project and partnership with Hatch Development. Project consists of 24 permanent and 8-10 emergency sheltering as well as office to provide oversight and include community space for post office boxes and heating and cooling centers. Bloomfield said these services are currently being provided through paying for hotel rooms in Clinton. Irwin said he visited a similar facility in Iowa City a few years ago. He said in Iowa City their top 24 users and top 4 users said they cost Johnson County \$2.7m over a few years. That included responding to calls and hospital visits involving these individuals. Irwin said this areas homeless population continues to increase and it was exasperated by the pandemic. He said family homelessness is also rising in Clinton County. Bloomfield said the hotel expenditures are \$65,000 during the colder quarter and it's about \$25,000 during the warmer months. She added many services cannot be delivered in a hotel setting. Srp said the need has increased while the ability to provide services has decreased. Bloomfield said when domestic violence sheltering funding was regionalized it went to Davenport and that decreased the ability to service people locally. YWCA did provide rapid rehousing, but that funding was also regionalized and went to other locations to provide affordable rental assistance. Irwin said this has been a long-time, on-going discussion during the last seven years. Irwin said this has been the most opportune time to apply for this federal grant to address this long-term issue. He said the City of Clinton has, along with the County, committed \$500,000 to this project. Irwin explained how this proposed location became targeted for this project. He said it is centrally located to many services that could support those using the facility. Irwin said it is possible the Clinton County Resource Center could be relocated to the YWCA facility. Bloomfield addressed a list of questions that were submitted previous to the public hearing.

The questions are followed by Bloomfield's responses:

What on-site staffing and management levels are expected at the housing project? Staffing at the project will include all Empowerment Center staff during the day, this will reduce current overhead costs, and provide additional staffing support to shelter support staff. Shelter staff will be on-site 24 hours/day as well as a "dorm monitor" that will live on-site.

Will this staff be on-site 24/7? Not all staffed positions will be 24 hours, however a shelter monitor and dorm monitor will be on-site.

Will there be private security personnel on-site around the clock? This is to-be-determined, but our current partner-ship with Clinton Police Department is proving effective and with our current set up it is requiring oversight as multiple locations instead of 1 or 2. And YWCA staff is not on-site at these locations 24 hours a day presently.

Are there any requirements like attending school or working to stay in the housing? No, this is a low barrier program. These resources are provided and STRONGLY encouraged but not required.

What is the plan for "bringing individuals back into the workforce"? Stabilization takes time, but each individualized plan involves mental and physical wellness, basic life skill development, including employment and financial management strategies. This varies per the individual and their needs. We already work closely with Iowa Workforce Development, and have a Women's Workforce Readiness Program that all clients have access to. We are also working closely to add vocational opportunities through local resources and 2nd chance employers.

Is there a maximum duration that someone can stay in the housing project? No, this is on an individualized basis.

Will child care be available at the housing project? Not on-site but access to our YWCA childcare will continue for our client's just as it currently is.

What is the budget for on-going expenses after construction and start-up? This is fluid at this time as we await responses of many grants that have been submitted for review, adjustments can and will be made as funding sources submit their award letters. A small portion of the NHTF application included a reserve fund so we will also have more information once that determination has been made.

What is the funding stream to pay for on-going expenses? Grants, the YWCA Empowerment Center (previously the DV Shelter) operates on a primarily grant funded basis for its many programs and will continue to do so in a

different building. This is not a new platform of operation for the YWCA and seeking diverse sources of funding is what we do, every year, regardless of location. We will also continue our partnership with the local Housing Authority and continue to serve the community mutually to best serve the most vulnerable with the resources available.

After the initial pledged payments from the city and county, are they committed to future payments? Yes, simply the current allocations that are pledged to the YWCA Empowerment Center would remain the same or similar amounts.

Eric Gettes, Clinton, lives near the proposed location. He is in strong support of this program as a former school board member. However, his concern is placing it in the middle of a residential neighborhood. He said there are several homes and a school facility in the area. He is concerned that placing it in the middle of a residential area is not a good idea due to the potential mental health issues and substance abuse issues that could be affiliated with this facility. He said home values do drop when facilities like this are located near residential areas. He encourages them to look for new locations. Carl Nord, Clinton, lives near project. Said he agrees with Gettes. Nord said this is currently zoned for residential. He said the intersection is busy and the proposed project will make it busier. Nord said the money spent on this project could be spent on the old YMCA building. He's opposed to it being placed in his residential neighborhood where children and families are located. He said his home value will go down if this is placed in his neighborhood. Sister Ruthie Westmorland said Sisters of St. Francis supports the project wholeheartedly and urged the Board to move ahead to transfer the property. They recognize they don't want homelessness in their neighborhood, but that's an issue around the world. Mike Yackshaw, Clinton, lives in the neighborhood and agrees with Gettes. He said he would like to see this project happen, but not in this neighborhood. Clinton Councilwoman Rhonda Kearns said she wants to make sure that crime is not being moved into the neighborhood and make sure the facility is open to the public. Curt Allen, County resident, expressed concern about expanding construction cost when it starts and asked about contingencies to avoid coming back to the taxpayers and asking for more. Andy Green, United Way director, supports the project. He said it is needed in the community. He said the people who would use this facility are now living in his neighborhood and hiding their things during the day around his neighborhood. He said no one wants to be in this situation and it could happen to anyone. He said this proposed project is located near services now. He said the mental health and substance abuse issues are now on our street and this project would address those issues. He said people can't get a job without an address or a shower before an interview. Green said the community very much needs this program. The Honorable David Sivright, Clinton YWCA board member, said when he was a judge he dealt with protective orders for women with children being abused and they came from neighborhoods you are talking about and they needed a place to be housed to get away from the abuse and this project will help address this. He said the folks receiving service from this project could come from any part of the city and any demographic. Sivright said he got to know someone receiving services, a veteran who lost his wife and lost his home. He now has an apartment after receiving assistance from the YWCA. Sivright said not all of those who will receive assistance are criminals or have mental health issues. He said if they do, they will receive treatment at the facility and many of those people are here and are currently on our streets now not receiving any services. Sivright called the project a step in the right direction. Dale Todd, Hatch Development representative, said he is proud of how far Clinton County has come along with this project. He said this community will look back on this project and realize it is something it will be proud of. He said as developer, their goal is to bring the project in on time and on budget. He said many other locations were reviewed and they tried to repurpose some buildings and found it was more expensive than to build new. He said there will be more neighborhood outreach as the project moves forward. He said these folks are in your neighborhoods now going through the alleys and garbage in the early morning hours. Todd is proud of the time and work the Clinton County Board of Supervisors have put into this project. Lori Gettes is in full support of the services, but said it will still affect their neighborhood's property values. She asked if other properties were reviewed. Bloomfield said they did review other properties and ran into financial barriers with those existing buildings. Todd said they work with neighbors to alleviate a lot of concerns. He said there are a lot of perceptions that they address. He said he really believes this facility will help stabilize this neighborhood. He said they wouldn't work on this project with someone who doesn't respect the neighborhood. Yackshaw suggested looking at other communities. Bloomfield said the obstacle with locating in other cities is being located near services. Nord asked what will happen if they are denied the permit to build the building. Bloomfield said they will review other options. Nord asked the Sister of St. Francis to donate land to for the facility. Srp said the St. Francis property isn't near services. Srp said the parking lot for the facility will be shared with the County for parking. Srp said that lot is rarely used by the County. The Board said they have received comments that have been addressed during the public hearing. Determann said others don't want a facility that will bring in more people from Illinois. Srp said the YWCA does a good job of screening those applicants now and expects that to continue. Jennifer Boyson, YWCA treasurer, said the finance committee has looked at other locations closely and agree this is the best option for the dollars. She added the Clinton School District alone said they have 90 homeless students.

Srp said the City of Clinton steered the discussion for locations and restricted the options for the development team. Srp said it makes sense to him to place this facility near the law center and the Clinton County Resource Center. He said he's attended several conferences as a Supervisor and the communities having success with this issue are doing it with a facility with a hub of resources like what this program could offer. Srp said the property was never zoned correctly with the city. He said there was a gas station in a residential area. But he said that is up to the City to decide. He said the City has committed to the project and would think the zoning committee would also be on board. Srp said Bloomfield has experience running a similar facility in a residential neighborhood in Rock Island. He said you would never know what that building was for by spending time in the neighborhood. Srp asked about what the land value would be for this transfer. Drew Chambers, representing the County, said the land is based on \$250,000 toward the project. Irwin reviewed how the value of the land was determined.

- 608 and 610 North 3rd Street, Clinton, Iowa 52732: The north thirty-two (32) feet of lot five (5) in Block fourteen (14) in North Addition to the Town, now City of Clinton, Iowa; and
- The South eight (8) feet of lot five(5) and the north twenty-three (23) feet of lot (6) in Block fourteen (14), North Addition to the Town, now City of Clinton, Iowa; and

WHEREAS, the Board desires to transfer the above-described real property on the terms and conditions outlined in Resolution 2022-223, and as specifically detailed the attached Option to Purchase; and

WHEREAS, the Board has determined that the transfer through the option to purchase meets a public purpose pursuant to Iowa Code Section 331.361(4) by addressing the county's homeless needs through the Board's general powers found in Iowa Code 331.301; and by creating measures in the Option to Purchase to provide the real property will be used for the approved public purpose; now

BE IT RESOLVED by the Board that pursuant to Iowa Code Section 331.361(2)(a) and (b), the transfer pursuant to the Option to Purchase of the above-describe real property as stated in Resolution 2022-223 shall be completed as outlined and the Chairman is authorized to sign as required.
