DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker asked the Board how it would like to schedule next week considering the Labor Day holiday. It was decided to not schedule a meeting unless needed. He said absentee voting has started for the Northeast Community School District Special Election. Van Lancker said absentee ballot requests for the November 8 General Election may be submitted starting tomorrow.

Supervisor Srp said the Clinton County Resource Center received the ISAC Excellence in Action award last week and it will be presented to the full board tomorrow morning.

Supervisor Irwin said they had good county supervisor meetings at ISAC last week. He said there were good discussions about pipelines going through counties around the state. He also mentioned the IUB will conduct a public meeting at the casino at 6 p.m. tomorrow about the carbon capture pipeline proposed for Clinton County.

County Treasurer Dustin Johnson said Clinton County is around the state average for vehicle titling, but he said that is starting to rise as more learn about the option. He said the senior property tax freeze is still being worked through.

Sheriff Bill Greenwalt said the firearms range they use will no longer allow them to use it. He said they are working on addressing that issue.

County IT Director Paul Banowetz reported the new website is scheduled to go live September 2.

DISCUSSION WITH POSSIBLE ACTION

Central Iowa Juvenile Detention Center Member County Program: Tony Reed, representative of the Central Iowa Juvenile Detention Center, presented information about the detention center's county program. He said there are 31 member counties now. He said they don't open membership up to all counties, but would like to invite Clinton County to join. He said Clinton County will then have a representative on the Board of Directors. Reed said Clinton County could realize some cost savings by being a member county. He said they also provide transportation. County Attorney Mike Wolf said Clinton County had been using Scott County due to location and costs. However, Scott County has gone to Scott County residents only. Wolf said Clinton County has started using the Iowa Juvenile Detention Center. He said membership comes with a financial advantage as well. Wolf said the per day rate at Central Iowa Juvenile Detention is considerably lower as a member. Sheriff Bill Greenwalt said the transport service would also provide a cost savings and would allow his office to be more flexible with his staff time. Wolf said the numbers of juveniles they are dealing with in Clinton County are increasing. Reed said there is no cost for membership at this time.

WHEREAS, Clinton County believes that it is in their best interest to join the Central Iowa Juvenile Detention Center, and

WHEREAS, Clinton County would not be assessed a membership fee to join; now

Charlotte Secondary Road Department Shed Location: County Engineer Todd Kinney reported he spoke with the County Attorney about how to divest in the former shed property in Charlotte. He said the city is interested in the property. He said the city will need to provide a letter to the County about what public purpose they would use it for if the County wishes to transfer the land to the city. Wolf said the County would still need to go through public notice/hearing process. Srp said he would like a good assessment on the land to know what they may offer to the City of Charlotte. Srp said the County should reach out to the city to see if they had a need for the property. Kinney said he will ask the city to respond in writing how they will use the land.

Canadian Pacific and KC Southern Railroad Merger: Chairman Determann said the City of Camanche was going to protest the merger due to safety concerns. He said a representative of Canadian Pacific could join the next Board meeting on September 12. He said there is a meeting tomorrow morning in Davenport of various interests against the merger. Determann said he will plan to attend that meeting. Srp said he would like the opportunity to ask questions of the railroad before committing to a letter of objection to the merger.
