DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker said in-person absentee voting continues Monday and then voting will take place at all polling locations on Tuesday. He said the Board will canvass the votes on Tuesday, November 15, at 1 p.m. Van Lancker said he also received the Moody's Investor's Service rating for the County, and it has not changed from last year. He said it is still a Aa2 which is the third highest rating and still in Moody's Prime category.

Supervisor Srp said a group of high school students visited the Courthouse last week to learn of the jobs that are done in the court system. He thanked all involved in taking the time to speak with the students. Srp said the first drug court graduation took place last week and congratulated everyone involved in that program. He reminded the Board to review appointments to boards and commissions.

Supervisor Irwin asked for a pipeline discussion to be scheduled for the November 21 agenda. Irwin said the County Pioneer Cemetery Commissioner reported that it has three more cemeteries that need stone refurbishment, but they are the larger cemeteries so their budget request may be larger than usual this year.

County Facilities Director Johnson said snow removal bids for the DeWitt office are due in this week. He reviewed dates for the process to start the Courthouse elevator project and the Administration Building window project.

DISCUSSION WITH POSSIBLE ACTION

Juvenile Detention Update: County Attorney Mike Wolf said the rate being charged at the detention center should factor in that they are dealing with potential detainees that may have issues and the cost should not go up based on how challenging a detainee may be. He said one juvenile has been refused altogether due to behaviors, however the Linn County facility has taken both. He said there will be three juveniles in detention after today. He said bed space in the state is day-to-day on availability. Irwin said he spoke with a representative of the Linn County facility. He confirmed that the hold rate is \$282 a day to reserve a bed. He said part of that reason is to cover overtime due to staff shortages. Wolf said having a bed reserved will best serve law enforcement as well. Srp suggested they consider Sheriff Greenwalt's previous suggestion of forming a committee to review how to meet this issue currently and how it can be addressed in the future. Wolf said the Board should still consider a contract with Linn County. Srp said that fee should also consider how much it will cost the Sheriff to transport a juvenile to a facility farther away than Cedar Rapids. Van Lancker reminded the Board to consider how the contract with Linn County may be budgeted. He said that amount in any budget will need another budget amendment for spending authority.

Secondary Road property in the City of Charlotte: Irwin said the City of Charlotte was wondering when they could complete the transaction for the land. Van Lancker said the formal process hasn't yet been followed for the County to dispose of the property. Wolf agreed the process for the County needs to be followed and he will prepare a resolution to set a public hearing.
