# RESOLUTION 2023-31

WHEREAS, the Clinton County Recorder is an elected official and the Board of Supervisors does not consider nor appoint personnel for elected officials, but need to authorize payroll for the County Auditor; now

THEREFORE BE IT RESOLVED by the Board of Supervisors of Clinton County, Iowa, that the County Auditor be and is hereby authorized to issue biweekly paychecks on the General Basic Fund, Office of Recorder to Amy Adney, as a full-time Clerk I. This will be in effect at an hourly rate of \$16.38 during the probationary period of six months, then increasing to \$16.96. Amy Adney's starting date of employment with the Recorder's Office will be February 6, 2023.

He said the dump truck fleet needs replacement more than graders. He said graders can wait a year as he has the rare opportunity to purchase two dump trucks this year. He said only one of three backup dump trucks are operational right now. Kinney suggested the Board change the resolution to purchase two dump trucks.

# RESOLUTION 2023-37

WHEREAS, Title VI of Civil Rights Act of 1964 provides that no person in the United States shall, on the grounds of race, color, national origin, or sex be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any program or activity receiving federal assistance (23 CFR 200.9 and 49 CFT 21); and

WHEREAS, the Civil Rights Restoration Act of 1987 broadened the scope of Title VI coverage by expanding the definition of terms "programs or activities" to include all programs and activities of Federal Aid recipients, sub-recipients, and contractors, whether such programs and activities are federally assisted or not (Public Law 100-259 {S.557} March 22, 1988); and

WHEREAS, Clinton County further assures every effort will be made to ensure nondiscrimination in all of its committees, programs and activities, regardless of the funding source; and

WHEREAS, Clinton County designates County Human Resources Director Alexandria Ellison as the Title VI Coordinator to be responsible for initiating and monitoring Title VI activities, and all other responsibilities as required; and

THEREFORE BE IT RESOLVED that County Human Resources Director Alexandria Ellison is here by designated as the Title VI Coordinator.

## DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reviewed the upcoming meeting schedule with the Board. He apologized for missing the original sheriff budget presentation for this afternoon, but it has been rescheduled for Tuesday afternoon. He said the Board has the state-wide Supervisors meeting on Thursday and more budget presentation on Friday. Van Lancker added the Hometown Banner Project was to be scheduled for consideration today but was waiting on an

auditor opinion about the potential contribution. He said he received that opinion late last week and will reschedule the banner project consideration for next week.

County Treasurer Dustin Johnson gave an update on the cross-county vehicle titling legislation. He said staff is starting to review potential remodel of his office.

Chairman Irwin said the Iowa Health and Human Services presented a report that was mostly negative about its mental health region. He said the region may have to speak to legislators about the report. He said some issues include the difficulty finding staff to provide services.

### DISCUSSION WITH POSSIBLE ACTION

County Administration Building Renovation Projects Including Windows, Heating and Cooling and Treasurer's Office Remodel: County Facilities Director Corey Johnson reviewed the window plans. He explained that he, Supervisor Srp and Van Lancker met with contractors a week ago. He said that meeting produced a suggestion that a full study of the building HVAC system be conducted. He said that study is estimated to cost \$6,000. Johnson said the study was recommended in case other upgrades are needed that could be physically connected to the window project and possibly done at the same time. He said the radiators on the walls must come off for the window project and the Board will need to decide how those are replaced. Irwin said the \$6,000 study sounds like a reasonable place to start. Srp agreed considering the scope of the project. Johnson said the windows need to be done to address energy efficiency and leaks in the windows on the north side of the building. Mike McNeil, Origin architect, said the study will help guide the window project. He said it could tell the County if the systems need to be adjusted that would change the window tints and number of windows replaced. Srp said balancing and zoning the climate control in the building is long overdue. Johnson said the study is expected to take 4-6 weeks.

MOTION by Supervisor Srp to authorize the chairman to sign the agreement for the climate control study by Modus and Origin Design for the Clinton County Administration Building not to exceed \$6,000 to be paid from the Administration Building Maintenance budget.

Development Agreement Update: Irwin said the attorney assisting the County with the agreement has sent a draft and he, Van Lancker and Johnson will review the draft this afternoon.

10:00 A.M. Public Hearing with Possible Action – Administration Building Window Project Chairman Irwin said the public hearing will be rescheduled for a later date due to potential changes in the project.

The Board of Supervisors adjourned to meet on Tuesday, January 31, 2023.
