RESOLUTIONS

The following resolution was presented and on motion approved:

RESOLUTION 2023-47

WHEREAS, the County has received a proposal from South Carolina Dialogue Foundation (the "Developer"), in the form of a proposed Development Agreement (the "Agreement") by and between the County and the Developer, pursuant to which, among other things, the Developer would agree to complete certain interior and exterior renovations (the "Minimum Improvements," as more particularly described in the Agreement) to the existing structure on the former Ashford University property (the "Development Property"), as outlined in the proposed Agreement; and

WHEREAS, Chapter 445, Code of Iowa, authorizes counties to enter into contractual agreements with the owner of legal title to real property in order to provide for a comprise or abatement of taxes on the real property, if the county is the holder of the tax sale certificate on the property; and

WHEREAS, there are approximately \$1,310,159 of outstanding taxes on the Development Property and the County is the holder of the tax sale certificate on the Development Property; and

WHEREAS, pursuant to the terms and conditions set forth in the Agreement, the County is willing to provide for a compromise and abatement of the real estate taxes on the Development Property to incentivize Developer to complete the redevelopment of the Development Property, subject to the Developer becoming the owner of legal title to the Development Property; and

WHEREAS, the proposed abatement of outstanding taxes on the Development Property would be made in five installments, as the Developer demonstrated that corresponding benchmarks of investment in the Minimum Improvements had been made, such that only if Developer demonstrated investment in the Minimum Improvements totaling at least \$1,310,158.75 (under the terms and conditions of the Agreement) would all installments of the tax abatement be granted; and

WHEREAS, the Board has determined that the Agreement is in the best interests of the County and the residents thereof and that the performance by the County of its obligations thereunder is a public undertaking and purpose.

NOW, THEREFORE BE IT RESOLVED, BY THE BOARD OF SUPERVISORS OF CLINTON COUNTY IN THE STATE OF IOWA:

Section 1. That the form and content of the Agreement, the provisions of which are incorporated herein by reference, be and the same hereby are in all respects authorized, approved and confirmed, and the Chairperson and the County Auditor be and they hereby are authorized, empowered and directed to execute, attest, seal and deliver the Agreement for and on behalf of the County in substantially the form and content now before this meeting, but with such changes, modifications, additions or deletions therein as shall be approved by such officers, and that from and after the execution and delivery of the Agreement, the Chairperson and the County Auditor are hereby authorized, empowered and directed to do all such acts and things and to execute all such documents as may be necessary to carry out and comply with the provisions of the Agreement as executed.

DEPARTMENT HEADS, ELECTED OFFICIALS AND EMPLOYEES

County Auditor Eric Van Lancker reported he, Sheriff Bill Greenwalt, County Attorney Mike Wolf and Emergency Management Director Chance Kness met informally last week to discuss the Medical Examiner program. He said from that discussion they decided it was their recommendation that a 28E agreement between the EMA Board and the County be delayed to review the program. He reminded the Board it has a public hearing in Lost Nation this evening. He said no budget work sessions have been scheduled. He added in person absentee voting starts this week for the March 7 Special Elections.

Supervisor Srp said a solar field safety meeting has been scheduled for March.

Supervisor George said she attended a meeting last night to discuss the possibility of two companies looking at railpark property in Clinton.

Chairman Irwin thanked Van Lancker and County Treasurer Dustin Johnson on their work on the development agreement.

Sheriff Greenwalt said he and Van Lancker heard back from Muscatine County who handles their ME program considerably different than Clinton County. He said they will likely meet with those folks for more information soon. Greenwalt said the Civil Service Commission will start their duties to test to create their hiring list for a year. He said a juvenile jail inspector visited Clinton's jail and said their policies and procedures are models for others in the state to follow.

County Facilities Director Corey Johnson reported he, Van Lancker and Srp will be meeting with the elevator replacement contractor on Wednesday.

County Conservation Director Phil Visser reported tree trimming at Rock Creek is almost complete and interviews for the open naturalist position are starting this week. He said they are also taking applications for part-time seasonal concession stand workers. Visser said a dredging project near Rock Creek has started with the permitting process and it could be more than a year before physical work begins.

County EMA Director Chance Kness said they have a number of events coming up including a mass casualty exercise in DeWitt and a school unification exercise in March with Clinton school officials. He said CERT classes are planned

for April and there are still a few openings. He said May 23 is the "off-year" exercise with the nuclear power plant in Cordova. He said they don't normally do the "off-year" but there have been recent changes that will be addressed this year.
