COOLING/WARMING CENTER POLICY

WHEREAS, the Board of Supervisors recognizes that the County Administration Building is a public building and is open to the public during normal business hours; and

WHEREAS, the Board also recognizes that during times of inclement weather, including excessive heat and periods of extreme cold, that individuals may not recognize that the Administration building is available as a resource to them without further notification; and

WHEREAS, when an Excessive Heat Warning or Extreme Cold Warning is issued, or is expected to be issued by the National Weather Service for Clinton County, a press release will be issued by the Emergency Management Agency on behalf of the Board of Supervisors and sent to local media outlets notifying the public of this service; now

THEREFORE, BE IT RESOLVED that the Board of Supervisors of Clinton County, Iowa, adopts the Cooling/Warming Center Policy dated January 2025.
