WHEREAS, the Medical Examiner for Clinton County has determined the need for Clinton County Medical Examiner Investigators; and has found Rodney Crowe qualified and appropriate for the position; and

WHEREAS, the Board of Supervisors has determined Rodney Crowe to be qualified and appropriate to be hired and appointed as Clinton County Medical Examiner Investigator. This appointment is contingent upon approval by the State Medical Examiner; now

WHEREAS, the Board of Supervisors has approved a budget in order to employ Medical Examiner Investigators, Rodney Crowe will receive the following:

- 1. A flat rate of \$200 per call. An hourly rate of \$26.00 for work greater than 6 hours with EMA approval.
- 2. Mileage reimbursement per the County policy.
- 3. An hourly rate of \$26.00 for training or for justifiable work at the discretion of EMA.

THEREFORE, BE IT RESOLVED that Rodney Crowe is hired and appointed as Clinton County Medical Examiner Investigator effective March 3, 2025.

RESOLUTION to AUTHORIZE the COUNTY AUDITOR to ISSUE REVISED BIWEEKLY PAY CHECKS for ASSISTANT COUNTY ATTORNEYS for FISCAL YEAR 2024-2025 PURSUANT to IOWA CODE

WHEREAS, Iowa Code Section 331.904(3) provides in part: "The annual salary of each assistant county attorney shall be determined by the county attorney within the budget set for the county attorney's office by the board"; and

WHEREAS, Iowa Code Section 331.757(2) provides in part: "The county attorney shall determine the compensation paid to a full-time prosecutor within the budget set for the county attorney's office by the board"; and

WHEREAS, Iowa Code does not authorize the Board of Supervisors to exercise discretion in the determination of the base salary for full-time assistant county attorneys; but, instead requires the Board to authorize the payroll (of each full-time prosecutor as determined by the county attorney) for the County Auditor; and

WHEREAS, the Clinton County Attorney's Office has determined the following revised annual salaries for fiscal year 2024-2025 are necessary (effective March 3, 2025) to provide public safety by helping to retain experienced prosecutors, as well as to recruit prosecuting attorneys in the future, given the current prosecuting attorney shortage:

APPROVE TAX ABATEMENT PURSUANT TO IOWA CODE §427.3 FOR SOUTH CAROLINA DIALOGUE FOUNDATION PARCEL #80-36060000

WHEREAS, the South Carolina Dialogue Foundation requests abatement of property taxes, fees, and interest due for the 2023 assessment year, which is reflected (payable) for the Fall of 2024 and the Spring of 2025 (hereinafter 2023 taxes) for real estate described on the attached deed (hereinafter parcel 80-36060000) and located within the City of Clinton, in Clinton County, Iowa;

WHEREAS, the Clinton County Board of Supervisors (hereinafter "Board") is authorized pursuant to Iowa Code § 427.3 to abate said property taxes, fees, and interest if the property would have been exempt under Iowa Code § 427.1(8);

WHEREAS, the South Carolina Dialogue Foundation Clinton property qualifies as exempt under Iowa Code § 427.1(8) as the real property's actual use has been solely dedicated for the appropriate objects of the charitable institution, namely, it is being renovated and upgraded for use as a nonprofit educational institution, for the period of abatement requested;

WHEREAS, the Clinton County Attorney has informed the Clinton County Treasurer regarding the Board's intention to abate the 2023 taxes, fees and interest on parcel 80-36060000.

WHEREAS, the Board desires to approve abatement of the 2023 taxes, fees, and interest levied against said property;

BE IT RESOLVED by the Board that, pursuant to Iowa Code §427.3, the property taxes, fees, and interest are abated for the 2023 tax bill. Specifically, the Clinton County Treasurer is authorized to abate the 2023 tax bill for parcel 80-36060000.

RESOLUTION APPROVING A MORATORIUM ON DATA MINING FACILITIES

WHEREAS, Data Mining is the commercial process by which volumes of data are analyzed to find patters, discover trends, and gain insight into how the data can be used; this shall constitute a commercial data mining operation; and

WHEREAS, the county has interests in protecting the county's infrastructure, natural resources, and property rights though our Zoning Ordinance, and Planning and Zoning Director along with the Planning and Zoning Commission will require time to gather information and coordinate with other agencies for the purpose of reviewing, updating, or creating ordinances, policies, and procedures relative to Date Mining Facility development; and

WHEREAS, the Clinton County Board of Supervisors shall enact a moratorium on the development and construction of Data Mining Facilities and on issuing application for zoning permits relating to the development and construction of Data Mining Facilities, from March 4, 2025 until September 1, 2025, which may be extended upon resolution of the Board of Supervisors, to allow the Board of Supervisors to adopt an ordinance that balances the rights of property owners seeking to have Data Mining Facilities on their property and be mindful of the health and safety of others.

NOW, THEREFORE BE IT RESOLVED by the Clinton County Board of Supervisors that the moratorium on the development and constriction of Data Mining Facilities, and applications for Zoning permits related to the development and construction of Data Mining facilities be in effect from March 4, 2025, until September 1, 2025; and

BE IT FURTHER RESOLVED that the Clinton County Board of Supervisors reserves the right to end the moratorium prior to the approved term of the moratorium by resolution.
