WHEREAS, the Clinton County Sheriff has considered the quotes received on February 25, 2025, for a camera and server/software upgrades to the Clinton County Jail Camera/Server Project (Section 1) with an additional three interview rooms (Section 3); (as listed in the quote) which need to tie into the same system, and

WHEREAS, the Clinton County Sheriff’s Office is aware of two companies that are capable of providing the server/software and camera/video equipment necessary to provide the upgrades in a timely and efficient manner, and

WHEREAS, the total amount of each quote received was as follows:
